



This past Sunday in he came - walking with only a simple wood stick to help him. That was enough for us to take in but, no, he was assigned to be the Epistle reader and up the aisle he WALKED and then, to put icing on the cake he walked up the aisle and up a step to receive communion. He has another two or three months before he can cast aside his braces but it will happen! Yes, we do believe in miracles and thank you Lee for reminding us of this blessing!

## **Lakeside Friends of Refugees**

Lakeside Friends of Refugees is closing in on the Welcome Corps application process. Its newest committee members, Mary Bell and Jim Kinley, have brought their expertise as former Peace Corps volunteers and trainers to help us achieve a necessary certification, plus the technical abilities required for personal signatures of the members to be attached to the online only application form.

Bobbi Perez, the coordinator of the group, has been meeting with Linda Beers, Essex Co. Public Health Director, and other Social Service Directors, to make sure that the committee members are ready to address the needs of the vetted refugees who we will be with us. She has stated that these groups are using what they are doing as a prototype for future refugees in similar circumstances.

Treasurer, Dick, has set up a "Lakeside Friends of Refugees" checking account at the Champlain National Bank and they plan to hold their first fundraiser - a bake sale, on April 8, in conjunction with the Town of Essex's tourism program.

The group's greatest need right now is finding suitable living accommodations for its future refugees. According to Welcome Corps, the two Spanish speaking men that we will accommodate will not be allowed even temporary housing with a committee member unless they are related to that person. Bobbi has asked Barb Davis, the assigned manager from the Integrated Refugees and Immigrant Services, to see if an exception can be made due to the circumstances of living in a rural area.

They ask that if you are spring cleaning and no longer need some cooking utensils, cutlery, linens, or simple furniture pieces, you put them aside for use when the men arrive.

They continue to thank everyone for their continuous prayers and support for this effort. There are no "OTHERS" among us as we honor Jesus who is present in every soul.

# Essex N.Y. May 4th 1905

Andrew J. Tucker presented financial report for the past year report showed balance of \$23.43 in Treasurer's hands. On motion report was rec'd & adopted.

Rev'd H. B. Whitney, Ervin G. Lyon & W. H. Cruikshank were continued as committee on repairs.

Cornelius DuBois & John B. Burnham were continued as committee on finance.

#### Essex, N.Y. April 27 – 1906

At an adjourned meeting of the Vestry held at the Rectory, this date – Rev'd H. B. Whitney presiding –

Committee on Electric Lighting of St. John's Church made report of work, report accepted and contract given for same to Leon Baker.

Treasurers report for past year showing a balance of \$108.05 in his hands rec'd and accepted.

# Essex N.Y. Nov 9th 1906

The following minute was adopted at Vestry meeting of said date Again we are called upon to witness the departure from this earthly life of one of the best and most valuable men from our small and diminishing number – Ervin George Lyon – Vestryman and sometime Warden of our Parish of St. John's, was a man of exceptionally sweet, pure and attractive nature, sterling character and a devoted and enthusiastic Churchman, being of an essentially

religious type of mind and heart -

Resolved – That we the Rector, Wardens and Vestry of St. John's Church, hereby record our unfeigned sorrow at the loss of so faithful a fellow Churchman and dear friend realizing that we shall sorely miss his unassuming but ever helpful presence form our services and our Councils, and his loving care for the beautifying of the sanctuary on the great Festivals of the Church, we also record our thankful appreciation of his quiet but steadfast example as a man, as a friend and a citizen of the community, praying our Heavenly Father for grace to follow the like course in our own daily life, and for our departed Brother rest and everlasting light in the Paradise of God.

# Essex N.Y. Feby 6th 1907

At a special meeting of the Vestry held this date at A. J. Tucker's store – Rev. H. B. Whitney, presiding.

Moved and seconded we ask for an appropriation of Three Hundred dollars from the Diocese to assist in paying the Rector's salary for the year 1907. Moved & seconded that St. John's Parish offer to make their usual contribution of thirty dollars toward the board of Missions Collection to be made in month of Sept.

## Essex N.Y. April 5th 1907

Treasurer's report received and duly accepted showing a balance of \$127.40 for fiscal year.

Moved Committee get estimates of needed repairs on Rectory.

# Essex N.Y. Jan'y 17th 1908

At a special meeting of the Vestry held this date at the Residence of A. J. Tucker. Rev. H. B. Whitney – Presiding.

Moved & seconded we ask for an appropriation of Three hundred dollars from the Diocese to assist in paying the Rector's salary for the year 1908. Moved & seconded that St. John's Church offer to pay their usual contribution of Thirty dollars towards the board of Missions, to be paid on or before Oct. 1<sup>st</sup> 1908.

Moved & seconded St. John's Church pay to the Bouquet Electric Light Co. \$9.00 per annum for lighting Chapel, commenced using same July 1<sup>st</sup> 1906. Moved & seconded H. H. Knapp be appointed Sexton St. John's Church – Moved & seconded John B. Burnham be authorized to purchase one dozen curtains for St. John's Church.

# Essex N.Y. April 4th 1908

Treasurer's report showing bal. of \$24.08 on hand was received & accepted. Moved & seconded the Clerk communicate with the Treasurer of St. Mary's Mission Willsboro requesting them to make good the balance due St. John's Parish Essex N.Y.

#### Essex N.Y. Sept. 25th 1908

At the regular meeting of St. John's Vestry held this date at the Home of A. J. Tucker the following being present;

Moved and seconded Lyman Thompson & John B. Burnham be appointed a committee to prepare a plan and the cost of same for flooring St. John's Church and report same to the Vestry.

#### Essex N.Y. Oct 3rd 08

At a special meeting of the Vestry of St. John's Church held this date at the residence of A. J. Tucker Warden.

Special repair committee report received.

Moved & seconded Leon Baker be awarded contract for roofing and flooring the Chapel for the sum of (225.00) Two hundred & Twenty five dollars. Moved & seconded Treasurer be hereby authorized to draw balance from Savings Bank, needed to complete the above repairs.
